

Mountain Side Recovery Rules and Fines

Signing this agreement is recognized as the first and only warning. Whether a person is fined or expelled from the facility immediately will depend on the severity of the rule that has been broken. The minimum fine for any broken rule is \$50.00.

1. Each person must sign an Authorization of Release of all Medical Information for 12 months. The release will be renewed every 12 months while staying at Mountain Side Recovery.
2. Each person will complete a medical questionnaire, and list 2 emergency contacts with names, address and telephone numbers.
3. Each person will complete their assigned chore(s) properly and completely.
4. Each person will keep all public areas and their bedroom clean and neat at all times.
5. There will be no sleeping in common areas, sleeping will be confined to your assigned bed.
6. No eating in the bedrooms and all dishes must be either washed immediately after use or placed in the dishwasher.
7. All complaints or grievances that can not be resolved between the parties privately will be discussed at the house meeting where each person can defend themselves.

8. All bedding will be taken to a coin operated laundry facility to be cleaned no less than once every 8 days.
9. No bedding will be washed or dried at Mountain Side Recovery.
10. No visibly soiled clothing or material such as construction materials, grease or oil will be laundered at Mountain Side Recovery, and instead will be taken to a public laundry to be cleaned.
11. All persons are subject to a random drug and alcohol testing at any time. If the test results are positive, you will be expelled from the facility immediately.
12. Each person will eat only their food, and use only their personal hygiene products.
13. Mountain Side Recovery will only provide transportation to and from work. All other transportation needs will need to be scheduled with SETHRA public transportation or privately.
14. All fees are due and payable every Friday by 6pm Eastern Standard Time.
15. When leaving the facility each person will sign in/out on the designated form.
16. Quiet time is from 10pm till 5am Eastern Standard Time.
17. No vaping or smoking is allowed inside the house or on the front porch. All vaping or smoking will be done on the back porch.

18. No cigarette butts or trash will be thrown on the ground, parking area, porches, or yard. All cigarette butts and trash will be disposed of in a proper waste bin.
19. There will be no congregating in the front of the home.
20. **EVERYONE** will sign the transportation release and it will be kept on file. **NO EXCEPTIONS.**
21. Mountain Side Recovery is **NOT** your Residence, it is a Fee based bed. No refunds of any type will be given.
22. Drug screens will be obtained post visitations and randomly.
23. Absolutely **NO** alcoholic beverages of any type are allowed to be consumed or in the facility.
24. All persons are required to attend a weekly Alcohol/Narcotics Anonymous class until completed.
25. Theft of any kind will not be tolerated, any person caught stealing will be expelled from the facility immediately.
26. No Narcotics, marijuana, or any type of THC, CBD, or convenience store purchased Psychedelic and/or psychoactive products widely known as “gas station drugs”, “legal highs”, “research chemicals”, “nootropics”, “dietary supplements”, “synthetic mushrooms”, “synthetic cannabinoids”, “synthetic stimulants, such as bath salts”, “Kratom”, “Tianeptine” or any other substances that can be used to alter mental states are allowed to be used or in the facility.

27. Mountain Side Recovery will not be held accountable for lost, stolen, or damaged items. All persons are responsible for their own belongings.
28. All persons are required to shower daily and keep themselves groomed at all times. All clothing must be washed regularly and bedding must be washed weekly.
29. Upon admission to Mountain Side Recovery Home, you will have a thirty day black out period. You may go to work, religious services, the grocery store, or NA/AA meetings with leadership or staff only.
30. Weapons of any kind are strictly prohibited. Any person found in possession of a weapon on their person or in their belongings is subject to immediate expulsion from the facility.
